SUPPLEMENTAL DECLARATION CONCERNING FRAUDULENT CLERK ACTIONS, RECORD TAMPERING, AND OBSTRUCTION OF FEDERAL NOTICE PRO NUNC TUNC, IN PERPETUITY, AD INFINITUM **NOVEMBER 18, 2025**

To the United States District Court and the federal clerk of record, let this supplemental declaration serve as a lawful and urgent notice regarding intentional administrative fraud and obstruction of filed jurisdictional transfer documents within local Arkansas courts.

Upon delivering formal federal filings and jurisdictional transfer notices to the Booneville District Court, the Clerk of Court accepted the filings, verbally confirmed that a copy would be made for court records, and returned the documents without

applying the proper district seal or acknowledgment of receipt. This act constitutes a failure to lawfully record federal transfer notice and is considered a willful omission designed to obscure or delay the acknowledgement of jurisdictional divestment. It further obstructs lawful record preservation under federal equity jurisdiction and violates court procedures governing document chain-of-custody.

The Greenwood District Court had previously received and stamped ECC-TRUST—JDC-005 documentation, confirming lodgment into the record. However, when the Sovereign Executor returned to verify and request copies, it was discovered that the court had manually scribbled out official court stamps on multiple pages of sealed documentation — including trust declarations, assignments, and jurisdictional exhibits — constituting an act of retroactive falsification of the court's own records. These actions are documented in photograph, notarized copies, and affidavit, and are hereby submitted into this federal case as evidence of institutional record fraud and jurisdictional sabotage.

These coordinated acts between clerks and officers across Booneville and Greenwood reflect a pattern of obstruction and concealment, in direct violation of due process, ecclesiastical trust law, and federal court authority. They additionally constitute tampering with federal jurisdictional notices already lodged in the above-captioned case and serve as evidence of ongoing state-level resistance to lawful equity enforcement.

No state or municipal actor shall alter, deface, ignore, or destroy sealed and filed federal court documentation. All participating clerks, judges, and administrative staff are hereby entered into record as parties with constructive knowledge of this obstruction. Any future denial, delay, or defacement shall be treated as an act of legal fraud and willful default.

This supplemental declaration is to be appended to Case No. 2:25-cv-02145-TLB, entered into the public record, and submitted to both the Western District of Arkansas Clerk of Court and internal review channels for further enforcement and prosecution.
