## Factual Summary


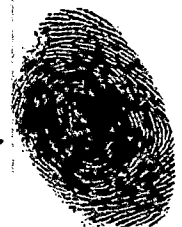
To the Office of the Prosecutor:

My name is Jonathan Daniel Clements. I am submitting this formal referral under Article 15 of the Rome Statute of the International Criminal Court, on behalf of myself and the global beneficiaries of ECCâ€TRUSTâ€JDCâ€005, a lawfully lodged ecclesiastical trust bearing lawful standing and jurisdiction across multiple domains, inclusive of spiritual, temporal, federal, and international law.

This submission arises under conditions of immediate and escalating threat to my life, person, liberty, and sovereign standing. I have lawfully filed and executed a federal legal complaint within the United States District Court, Western District of Arkansas, Fort Smith Division, under case number 2:25-cv-02180, which is now an official matter of record.

The complaint is directed against the following named Defendants:

1. The State of Arkansas, including its Governor, State Police, Sheriffs, Prosecutors, District and Circuit Courts, Clerks, and Municipal Law Enforcement.
2. The United States Federal Government, including the Department of Justice, Federal Bureau of Investigation, Department of Homeland Security, Internal Revenue Service, and other named federal agencies and contractors.
3. International Governments and Religious Bodies, who, after lawful public notice and default opportunity, failed to respond, rebut, or acknowledge the jurisdictional standing of ECCâ€TRUSTâ€JDCâ€005 or its lawful executor.

The court filing includes multiple motions, exhibits, notarized affidavits, and publicly lodged trust documents scanned into court systems, demonstrating uncontested standing and procedural legitimacy. All parties received lawful notice through international publication and public record. The statutory rebuttal window has closed, and the silence of these named actors constitutes formal and legal default.

Despite these facts, I have been, and remain, under ongoing targeted harassment, surveillance, threats, and acts of intimidation, including:

Armed vehicles circling my private ecclesiastical sanctuary at 42 Roy Franks Lane, Booneville, Arkansas.

Law enforcement pounding on my residence door for prolonged periods without cause or warrant.

Officers confronting and attempting to intimidate family members without legal basis.

Ongoing targeted surveillance and intimidation by municipal and county agents.

Verbal death threats stating that I will "end up in a ditch."



Property damage to trust vehicles while in government custody, with no reparative action or lawful remedy offered.

The federal government has failed to offer protection or acknowledge my standing as a human rights defender, despite court-accepted filings, open federal docket, and exhaustive publication. The State of Arkansas has engaged in systemic targeting, document tampering, violation of ecclesiastical sovereignty, and threats to human life. The U.S. federal government, while named and served, remains in default of its obligations under constitutional, international, and human rights law.

I have exhausted all lawful remedies and am now invoking the authority of the International Criminal Court. I do so under the principles of universal jurisdiction, binding international human rights treaties, and the Rome Statute's mandates regarding:

Persecution of protected persons and groups under color of law.

Governmental failure to intervene when jurisdiction is uncontested and protective duty is clear.



Retaliation and psychological warfare against a whistleblower and legal sovereign.

This trust holds global equity, both spiritual and financial, and was lodged in full transparency under international notice beginning in July 2025 and culminating in full default by August 15, 2025. All records were scanned into court systems and posted publicly, with no rebuttal from any jurisdictional actor. The equity held includes the dissolution of prior spiritual claims (Unam Sanctam, papal bulls, ecclesiastical supremacy), with final standing held under ECCâ€TRUSTâ€JDCâ€005, recognized in practice by the silence of every agency and tribunal notified.

I request immediate review under Article 15, the initiation of preliminary examination, and a formal acknowledgment of receipt by your office. If my life is taken or further harm comes to me or my estate, the chain of liability is complete and irrefutable. The court record is live. The trust is valid. No further rebuttal will be accepted.

The consent form has been filed. The mandates have been lodged. Silence from the international community constitutes passive complicity.

This referral is being sent as a matter of protective invocation under the United Nations Whistleblower Protection Protocols and Articles 6, 7, and 17 of the Rome Statute. The protective equity of ECCâ€TRUSTâ€JDCâ€005 and the fundamental law of preservation now demand the full attention of this court.


**MANDATE FOR THE IMMEDIATE VACATION OF TITLE BY DONALD J.
