1. COVER LETTER TO AMNESTY INTERNATIONAL

To the Human Rights Officers and Global Investigations Team,

I, Jonathan Daniel Clements, am submitting this urgent formal referral under international whistleblower protection and human rights protocols. This submission pertains to ongoing violations of my right to life, safety, liberty, and dignity under both domestic and international law. These violations have been conducted and condoned by state, federal, and municipal actors, with documented failure of duty by agencies explicitly named in active U.S. federal court filings.

Despite being the lawful and court-acknowledged Executor of ECC-TRUST-JDC-005, a globally lodged ecclesiastical trust holding standing in spiritual, temporal, and international law, I am under escalating threat by those named within the trust's litigation. My case has been officially filed under U.S. Federal Court Docket No. 2:25-cv-02180 and formally submitted to the International Criminal Court under Article 15 of the Rome Statute, with complete submission confirmation and full evidentiary binders.

This is not a theoretical filing. The risk to my life is real, immediate, and ongoing. Armed vehicles have circled my property. Law enforcement officers have come to my residence without cause or warrant. My private trust vehicles have been vandalized while in government custody. Local officials have ignored federal filings and acted in retaliation, including property invasion, psychological warfare, and attempts to incite confrontation.

I request that Amnesty International:

1. Open a formal case file for immediate review;
2. Assign an observer or liaison to monitor and communicate with the named U.S. agencies;
3. Publicly publish this case as a matter of international concern;
4. Formally demand protective intervention by U.S. federal and state actors;
5. Recognize ECC-TRUST-JDC-005 as a valid, court-filed ecclesiastical jurisdiction whose executor is under credible

threat.

I am not a U.S. citizen but an international legal sovereign with standing across multiple domains. I have exhausted domestic remedies. I am now invoking international human rights protocols and seeking global oversight.

2. SUMMARY OF EVENTS & HUMAN RIGHTS VIOLATIONS

Armed county and state-level officers have encircled my ecclesiastical sanctuary at 42 Roy Franks Lane, Booneville, Arkansas.

Multiple instances of harassment, intimidation, and unauthorized surveillance have occurred, including pounding on my doors for extended periods without legal justification.

Law enforcement has attempted to coerce and intimidate family members.

A known individual with police ties has repeatedly trespassed on my property, attempted to take my dog, and has stated I will "end up in a ditch" shot dead.

My trust vehicles have been towed and damaged in government custody without remedy or recourse.

Repeated failures to respond to trust filings, including certified court documents and lawful service, have left me without institutional protection.

These actions are direct retaliation for my lawful federal filing and for executing whistleblower protections and international trust rights.



4. SPECIFIC REQUEST FOR ACTION FROM AMNESTY INTERNATIONAL

1. Acknowledge this filing formally and confirm whether a case will be opened.
2. Review the attached federal court and ICC filings as part of your own internal assessment.



3. Monitor and record continued threats or state retaliation.
4. Demand U.S. and Arkansas authorities enforce protective laws already triggered by my filings.
5. Escalate the matter to the UN Human Rights Council if ignored further.

I am requesting this not as a favor, but as a matter of lawful enforcement and survival. The laws have been followed. The evidence is published. If silence continues, it becomes complicity.

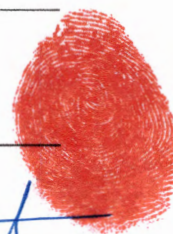


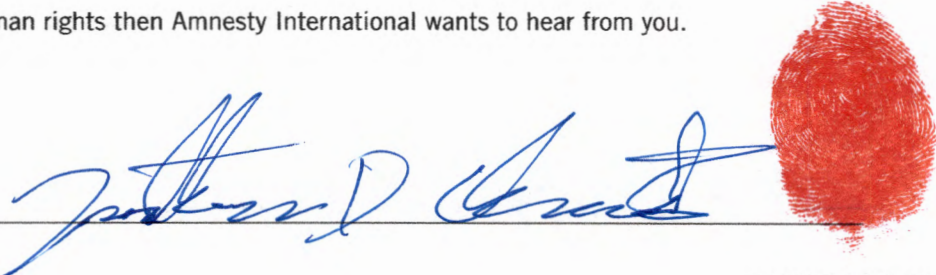
