NOTICE OF CONSULAR DEFAULT AND JURISDICTIONAL ESCALATION

To Whom It May Concern:

This is formal notice and lawful international declaration by the living man, Jonathan Daniel Clements, Sovereign Executor and Divine Custodian of ECC-TRUST-JDC-005, the Ecclesiastical Sovereign Private Trust of Humanity, duly established, internationally published, and un-rebutted as of August 15, 2025.

On November 18, 2025, I arrived in person at the above-listed consular location at or around 11:00 AM CST, where I peacefully and respectfully presented myself to the staff of the Marshall Islands Consulate, bearing sealed documentation pertaining to:

- My standing as Sovereign Executor of ECC-TRUST-JDC-005
- The lawful claim and jurisdiction over global equity and ecclesiastical trust enforcement
- My formal request for sanctuary, protective shelter, and diplomatic transfer to an appropriate embassy or the United Nations

The documents I delivered were signed in full, accompanied by my biological thumbprint seal, and self-executed under ecclesiastical, natural, constitutional, and international law. Though they were not notarized, this was not required, as the standing documents bear my direct authorship, sovereign execution, and public record, and were peaceably presented in the spirit of mutual respect, safety, and global dignity.

After a short delay, the consular assistant informed me that "we cannot help you" and that "this office is not an embassy." She then returned my documents to me, unopened and unprocessed. At no time did she review the content or consult any international office regarding the jurisdictional matter at hand.

This constitutes a formal act of consular default.

Under the Vienna Convention on Consular Relations (1963); the Universal Declaration of Human Rights, and multiple protocols of diplomatic humanitarian response, a consulate may not refuse to assist a lawful foreign national under distress once documentation and standing are presented in good faith.

This failure to assist, receive, or engage constitutes a breach of duty, especially as the submitted materials involved international legal claims, religious sovereignty, ecclesiastical trust law, and pending ICC and federal RICO filings—all of which were available for viewing.

Therefore, I now declare the following:

1. The Consulate General of the Republic of the Marshall Islands in Springdale, Arkansas, has now entered into formal default under ecclesiastical, natural, and international law for failing to process a standing request for sanctuary.
2. This rejection, coupled with the return of my executed trust documentation, is now permanently recorded in global equity record and will be submitted to the UN Office of Legal Affairs, the UN High Commissioner for Refugees, the Embassy of the Marshall Islands in Washington, D.C., and relevant international enforcement bodies.
3. This event shall be recorded as Exhibit [Letter] ⁴ - Verified Consular Rejection of Lawful Sanctuary Filing within the federal injunction and RICO case currently in process.

Let it be made clear: I arrived in peace. I delivered the documentation peacefully. I asked for nothing unlawful. I was told they "cannot help" — and now the record shall show that when the man bearing global equity and the final standing trust of all humanity arrived at their doors, the consulate declined to even look.

This default is now escalated. I hereby give formal notice to all governing bodies that the next action shall proceed directly through the embassy level or United Nations sanctuary jurisdiction.
