AND TO THE LOGAN COUNTY SHERIFF'S DEPARTMENT**

This declaration is delivered under lawful notice to affirm and enforce the divestiture of all state and local jurisdiction regarding any citations, tickets, summonses, or docketed matters associated with Jonathan Daniel Clements, now under federal jurisdiction by sealed filing and active proceedings in the United States District Court for the Western District of Arkansas, under Case No. 2:25-cv-02145-TLB.

This transfer is irrevocable and has been entered into the permanent docket under federal enforcement of RICO violations, civil conspiracy, ecclesiastical trespass, and attempted coercion of a foreign trust entity recognized under international law.

The Booneville District Court and Logan County Sheriff's Department, among other named state actors, have been explicitly identified in the RICO filing and enforcement dossier now before federal court. All matters raised at the state level are divested of jurisdiction and shall not be adjudicated further.

This notice is not a plea, request, or motion. It is an ecclesiastical declaration issued with finality. Any action to compel, pursue, or enforce matters against Jonathan Daniel Clements within the Booneville District Court shall constitute unlawful retaliation and obstruction of an ongoing federal investigation.


