**TO THE UNITED STATES DISTRICT COURT, AND TO ALL FEDERAL,
STATE, AND INTERNATIONAL AGENCIES NAMED IN THE RECORD:**

This emergency declaration is issued under sovereign and ecclesiastical authority by
Jonathan Daniel Clements, Sovereign Executor of ECC- TRUST-JDC-005, in lawful
standing and pro se capacity, for the immediate invocation of injunctive relief against
unlawful wiretapping, phone interference, and electronic harassment perpetrated by
actors within both government and non-government sectors.

Ongoing attempts to surveil, interfere with, and electronically harass the undersigned
have risen to a level of sustained psychological warfare, communication sabotage, and
unlawful monitoring — without any valid warrant, lawful consent, or jurisdictional
authority to do so.

These violations have occurred across multiple platforms and jurisdictions, including
but not limited to:

Tampering with telecommunications devices and internet access;

Illicit geolocation tracking and stalking via network intrusion;

Unauthorized warrantless data interception and packet logging;

Exploitative behavior against personal privacy using federal, state, and international networks;

Coordinated attempts to intimidate, coerce, and disrupt legal filings, federal proceedings, and sovereign communications.

The actions above constitute clear violations of the Fourth Amendment to the United States Constitution, the International Covenant on Civil and Political Rights, the Universal Declaration of Human Rights, and multiple sections of the Electronic Communications Privacy Act (ECPA), in addition to constituting **spiritual trespass** and violations of ecclesiastical sanctuary jurisdiction.

The trust has already divested the presumption of corporate or commercial authority, and all actors — federal, state, or international — have been placed on permanent notice. The trust retains exclusive lawful jurisdiction over its records, communications, estate, and biological estate.

Accordingly, I request this Court immediately recognize and affix record to the following relief:

A federal injunction barring any agency, private contractor, foreign state, or entity from engaging in surveillance, wiretapping, spoofing, or intrusion of any kind into the private affairs, communications, or digital systems under the custodianship of Jonathan Daniel Clements or ECC- TRUST-JDC-005;

Federal enforcement to protect the trust's ecclesiastical records, devices, transmissions, and secure communications — whether verbal, digital, electronic, visual, or metaphysical;

Referral of all involved parties, including intelligence contractors, law enforcement entities, or foreign surveillance participants, to appropriate federal and international review.

All prior trust filings, recordings, affidavits, and declarations already submitted under Case No. 2:25-cv-02145-TLB are hereby incorporated by reference into this declaration, and this submission shall be immediately sealed and acknowledged by the Clerk of Court.

Any further interference or refusal to act shall constitute a violation of the court's fiduciary duty and an international escalation event.


