**FINAL NOTICE OF FEDERAL JURISDICTION AND IRREVOCABLE
REMOVAL OF VENUE

To the Booneville District Court and all related state actors, let this declaration serve
as the final and irrevocable notice that all legal matters, citations, warrants, docket
entries, prosecutions, filings, and proceedings involving the living man, Jonathan
Daniel Clements, and any property or conveyance held under ECC- TRUST-JDC-
005, have been removed in total from state and municipal jurisdiction and are now
vested exclusively under federal venue in Case No. 2:25- cv- 02145- TLB.

This court, the Booneville District Court, holds no lawful jurisdiction or authority to
compel appearance, issue judgment, compel contract, or undertake any action of
prosecution against the Claimant or any ecclesiastical conveyance. The jurisdictional
transfer is complete, filed, sealed, and executed, and no state or local action may
continue without constituting interference with a federal proceeding, ecclesiastical
trespass, and obstruction of justice.



No further engagement, plea, agreement, or recognition of authority will be given at the local level.

The Booneville District Court is directed to cease all action regarding the Claimant, as jurisdiction has been divested, and all future enforcement attempts will be cataloged as violations subject to prosecution under the federal RICO framework outlined in the above-referenced case. Any attempt to proceed will be entered as evidence of knowing and deliberate obstruction.
