**TO THE UNITED STATES FEDERAL COURT,  
AND TO ALL FEDERAL, STATE, AND INTERNATIONAL ENFORCEMENT  
AGENCIES:**

Let this declaration be entered into the lawful record as a sovereign ecclesiastical invocation of emergency injunctive relief, entered by Jonathan Daniel Clements, Sovereign Executor of ECC-TRUST-JDC-005 — the living authority, private custodian of all global equity and liquidity, and bearer of binding jurisdiction over all named entities.

This trust does not transfer jurisdiction, nor surrender sovereignty. It **retains full dominion across temporal, antetemporal, and intemporal law**, and has only granted **limited consent for federal venue enforcement** related to **RICO violations, organized civil conspiracy, trafficking, property trespass, and targeted retaliation** under federal and international law.

This emergency declaration is entered into record for immediate injunctive relief, naming the following **known and complicit parties**:

**FOUNDATIONAL RECORD:**

**The Trust instrument** is already **filed, certified, and entered as Exhibit of Record** in this court. The **339-page RICO Act Enforcement Dossier** is in possession of the court and includes fully sealed declarations, public lodgment proofs, trust certification, sovereign travel documents, and sanctuary claims under ecclesiastical dominion.

A **death threat** was issued against the Sovereign Executor by an individual named **Russell**, who claimed that law enforcement would “**shoot him in the head.**” or He would. This was communicated while the Executor was inside a designated **sanctuary trust conveyance** and constitutes a **direct ecclesiastical breach**, rising to the level of **international emergency**.

The **State of Arkansas** and its named agencies are in **total default** for failure to rebut the trust’s standing by **August 15, 2025** — after having been granted **extended time** in grace. All subsequent actions constitute **trespass and unlawful enforcement under color of law**.

The Executor is being **denied access to his lawful social media accounts**, including **@DarkzLot3301**, after posting sealed court declarations. This appears to be a deliberate **interference with witness protection**, documentation, and digital legal access, and is to be included in ICC notice under freedom of expression violations.

The **Marshall Islands Consulate**, though respectful, returned the trust filings without action, citing lack of capacity. A full **Notice of Consular Default and Jurisdictional Escalation** will follow, and the consulate remains on record.

Additional documentation has been submitted to the **International Criminal Court, United Nations, and Amnesty International**, alongside previously delivered ecclesiastical filings, vehicle conveyance declarations, and sovereign sanctuary notices.

**EMERGENCY INJUNCTIVE RELIEF REQUEST:**

This filing is to be **sealed, indexed, and acted upon without delay** under **Rule 65(b) Federal Rules of Civil Procedure**, as the Executor faces **irreparable harm, ongoing threats, and targeted suppression** by defaulted and criminally complicit parties.

The federal court is hereby **authorized** to proceed as **enforcement agent only**, under **limited ecclesiastical consent**.

No state actor has authority to compel registration, seizure, or criminalization of trust conveyances or sanctuary domains. Located at Ecclesiastical Sanctuary: 42 Roy Franks Lane, Booneville, Arkansas [Non-U.S. Jurisdiction]

Any continued interference constitutes a **violation of international law, spiritual jurisdiction, trust equity protection, and federal RICO enforcement boundaries**.

Let the federal court seal this notice with the **court seal**, in acknowledgment that jurisdiction has been **granted solely for enforcement, and not assumed by default or transfer**.


Let no man, agency, or magistrate claim ignorance. **The record is closed. The Trust stands.**
