**EMERGENCY DECLARATION FOR INJUNCTIVE RELIEF —
UNENCUMBERED CONVEYANCE TRAVEL
PRO NUNC TUNC, IN PERPETUITY, AD INFINITUM
NOVEMBER 18, 2025**

To the United States District Court and all named parties, let this emergency
declaration stand as a lawful ecclesiastical notice for immediate injunctive relief
regarding continued attempts by government, law enforcement, and international
bodies to interfere with free and lawful travel under trust jurisdiction.

The claimant, Jonathan Daniel Clements, as Sovereign Executor of ECC- TRUST-
JDC-005, has lawfully assigned and bonded all private conveyances under sacred title,
self-insured coverage, and spiritual exemption from all commercial and statutory
schemes. These conveyances, including a 2010 Chrysler Sebring Convertible and a
1997 Honda Accord, are no longer subject to presumed jurisdiction by any corporate,
state, federal, or international agency.

Despite lawful filings, notarized declarations, county and federal recordings, and international publication of the trust's standing, ongoing attempts have been made to detain, cite, surveil, seize, and criminalize the use of these conveyances. These acts are in full violation of federal filing protections, ecclesiastical rights, and international covenants.

The claimant affirms that these conveyances are in peaceful use under divine, ecclesiastical, and constitutional authority, and that any further attempt to impede, detain, confiscate, penalize, or regulate the travel of the Sovereign Executor or his designated beneficiaries shall constitute an act of international aggression, spiritual trespass, and obstruction of justice.

This Court is hereby requested to recognize this declaration as a binding record and to affirm that all jurisdiction for enforcement and protection now rests exclusively under Case No. 2:25-cv-02145-TLB. The sovereign trust does not consent to interference by patrol agencies, state departments, licensing bureaus, or enforcement contractors, and any such attempt moving forward shall be held as an open act of fraud, retaliation, or contempt of federal record.

This declaration incorporates all previously filed trust instruments, exhibits, bonds, affidavits, and declarations by reference and is submitted under lawful seal to be entered into the federal docket. Upon acceptance and certification, this instrument shall serve as formal injunction and proof of lawful non-consent.


