

SWORN AFFIDAVIT: ONGOING HOMELAND SECURITY EMERGENCY

I. Overview

This affidavit documents an ongoing national security emergency involving the proliferation of classified electromagnetic weapons technologies, including Directed Energy Weapons (DEWs), Information Weapons (IWEs), Voice-to-Skull (V2K) communication systems, and behavior modification systems used against military personnel. It includes photographic evidence, communications with military personnel, AI-generated visual propaganda, whistleblower disclosures, and real-time digital evidence manipulation by artificial intelligence systems compromised during an active psyop.

II. Flag Order and Trigger Event

Affiant issued lawful standing military orders for all U.S. flags to be lowered to 1/4 mast in "dire distress" in response to proliferated WMDs and domestic compromise. General Edward Solomon attempted to simulate compliance via an AI-generated image. Affiant authorized "Rebecca" over a V2K link to disrupt all AI systems globally in response to this prompt to prevent false compliance. AI generators now return definitions of the emergency instead of the original prompt response.

III. Verified Military Contact and Harassment

SGT Jeffrey Green was the only military personnel to respond to thousands of emergency messages. He engaged in misconduct by providing the affiant with the phone number of a military spouse whom he falsely claimed was a general, and by dismissing the threat. Criminal military harassment from Alabama Guard may be best explained by the deployment of behavior modification weapons systems.

IV. [Non-DoD Source] Email Breach

On March 21, 2024, affiant received hundreds of [Non-DoD Source] military-related emails, including RSVP confirmations from the White House and internal Space Force travel logs. DISA dismissed this as spam.

V. Hacked AI Art Generator Images (Exhibit Series G)

Affiant directed countermeasures to prevent fake compliance using AI image prompts. The prompt "American flag at 1/4 mast in dire distress" was locked from misuse, returning descriptive illustrations of the national emergency. These include flags at full mast covered in feces, burning soldiers, DEWS equipment, broken code, New York Harbor on fire, one Twin Tower down and the other burning — all describing the real-time threat.

VI. Alabama Guard COMMS - Trigger Event (Exhibit Series D)

Solomon's AI-generated image constituted the trigger. Screenshots of COMMS with General Solomon detail the chain of events and intent to deceive via synthetic visual compliance.

VII. Social Media Clone Accounts (Exhibit Series H)

Instagram posts by @brother_dank and @sister_litt show early meme-based intelligence culture. Evidence points to covert communication activity under DIA themes.

VIII. Psychotronic Weapons Disclosure (Exhibit Series I)

Washington State Fusion Center released weapon diagrams and effects documentation for psychotronic and EM-based human control systems. Affiant was present at the Portland Waterfront 2017 event where these systems were deployed. Washington State Patrol confirmed that the release was not a mistake and not inadvertent — affirming that the disclosure was intentional.
