PACTS, INTERNATIONAL'S LETTER OF VALIDATION FOR MR. DAVID LUCITO

Dear Reader,

PACTS International is a 501 (c)3 non-profit organization established to assist and support victims of Havana Syndrome experiencing neurological issues from directed energy weapons abuse and the stalking and harassment that often accompanies it. Currently, there is no government support for victims of Havana Syndrome -- such as Mr. David Lucito, who are civilian citizens, nor are there procedures and methods established to assist those victims.

Although PACTS International is not medically licensed, nor can we diagnose or offer medical advice for Havana Syndrome, we are in a unique position to offer conference call support and access to local support groups for those who believe they are victims of Havana Syndrome. Our victim community is extremely familiar with the neurological symptoms experienced daily by over 5,000 members reporting similar effects.

Havana Syndrome is a traumatically debilitating condition caused by neurological weapons. More specifically, Havana Syndrome is a brain-computer interface (BCI) that allows the user to eavesdrop on and influence thoughts, behaviors, input constructed voices and manipulate neurobiological systems, feelings, senses and more with radio frequency weapons. The former United Nations Special Rapporteur on Torture, Nils Melzer, investigating victims' claims, coined the term "cybertorture" in 2020 to describe the neurological attacks from directed energy weapons.

David Lucito has come to our organization seeking assistance and a Letter of Validation from PACTS, International for his suffering. I have conducted a thorough evaluation of Mr. Lucito that included a Havana Syndrome survey, and a one-on-one interview whereby we acknowledged that he is a victim of neurological weapons abuse. During this review, he indicated that he is experiencing neurological symptoms similar to those of the US diplomats targeted around the world with Havana Syndrome as delivered by directed energy weapons.

We can certify from David Lucito's responses in the interview and given on our survey that it is statistically likely that he suffers from neurological issues associated with Havana

Syndrome due to the generally accepted belief by several government reports that the US diplomats' symptoms are most plausibly the result of "directed, pulsed, RF (radio frequency) energy..." This theory is also supported by a CNN special report hosted by Dr. Sanjay Gupta which aired on September 22, 2022. Dr. Gupta interviewed an array of medical and engineering experts, most all of whom verified that what the US diplomats are experiencing is "probably some form of directed energy." Our organization was formed to advocate for victims, educate the public, and bring awareness of the illegal activities of the perpetrators of directed energy weapons abuses. We are seeking legislation, protection, and freedom for victims of this new crime of cybertorture.
