Honorable Members,

I write as a Christian Minister, Material Witness, and targeted survivor of military-grade information weapons assaults by the U.S. government (detailed in my sworn affidavit at [tinyurl.com/schizophreniaisaweapon](https://tinyurl.com/schizophreniaisaweapon)), to urgently warn of the profound betrayal unfolding on the legislature floor. A bill is advancing to hand recreational cannabis control to the same predatory duopoly until 2030, extending a system of exploitation that denies Louisianians their God-given right to the Tree of Life for healing, while the legislature itself is allegedly infested with Havana Syndrome—neurological WMD attacks causing brain injury, cognitive disruption, and manipulated decision-making ([tinyurl.com/phialphsausea](https://tinyurl.com/phialphsausea)).

This bill is not mere policy; it's a continuation of genocidal fraud rooted in Nazi Antichrist programming designed to destroy our Church, Republic, and health. Five years ago, I testified before the Louisiana Medical Marijuana Commission (attached documents), commanding in Christ's name: "Pursue our only legal option; let my people grow!" Cannabis is a dietary essential for the endocannabinoid system ([tinyurl.com/dietaryessential](https://tinyurl.com/dietaryessential)), preventing cancers, enhancing empathy, and treating needless sickness ([tinyurl.com/clinicalED](https://tinyurl.com/clinicalED), [tinyurl.com/maternalcare](https://tinyurl.com/maternalcare)). Without it, we die prematurely from deficiency diseases. Yet the duopoly charges \$100,000–200,000 for a full kilo Rick Simpson protocol ([tinyurl.com/anslingernazi](https://tinyurl.com/anslingernazi))—medicine that costs \$400 to produce—leaving the sick to suffer while insurance skirts coverage.

The origins of prohibition are lies from Henry Anslinger, a racist Nazi traitor who gutted our nation's health ([tinyurl.com/fraudnegatesconsent](https://tinyurl.com/fraudnegatesconsent)). Cannabis is the biblical Tree of Life, removed by lying scribes ([tinyurl.com/Jeremiah8](https://tinyurl.com/Jeremiah8), [tinyurl.com/bennettcannabis](https://tinyurl.com/bennettcannabis))—for the healing of the nations, with no curse remaining ([tinyurl.com/edenrestored](https://tinyurl.com/edenrestored)).
