- Brain changes are SECONDARY adaptations to chronic EM exposure
- Structural differences are biomarkers of targeting, not disease causation

This distinction matters because:

If brain changes CAUSE symptoms → treat the brain (pharmaceuticals, targeted interventions)

If EM weapons CAUSE symptoms AND brain changes → brain differences are evidence of external attack, not proof of endogenous disease
