NOTICE OF FILING EVIDENTIARY EXHIBIT IN SUPPORT OF ALL PENDING MOTIONS: "A LITANY OF THE FAITHFUL"

NOW INTO COURT, comes Reverend David Edward Lucito, appearing as Next Friend for the Defendant, Caroline Nicole Harris, who hereby files into the record the attached evidentiary exhibit, entitled "**A Litany of the Faithful**," and requests the Court take judicial notice of its contents in considering all pending and future matters in this case.

I. PURPOSE AND RELEVANCE OF THE EXHIBIT

This exhibit, "A Litany of the Faithful" (hereinafter "The Litany"), is a meticulously researched historical document. It establishes an undeniable, century-long pattern wherein individuals who discover, invent, or expose inconvenient truths—particularly those related to classified technologies and their effects on human beings—are systematically silenced, discredited, and destroyed by state and corporate actors. **The Litany demonstrates that the primary weapon used to achieve this silencing is the deliberate, pretextual weaponization of the medical and psychiatric systems to label truth-tellers as "mentally ill," "delusional," or "insane."**

The names cited within The Litany—from Nikola Tesla and Royal Raymond Rife to James Forrestal and the victims of MKUltra—are not mere historical footnotes; they are predicate evidence. They establish a clear *modus operandi* that is being redeployed against Caroline Nicole Harris.

II. CONNECTION TO ALL PENDING MOTIONS

This exhibit provides the crucial context—the **motive**—for the State's otherwise inexplicable actions in this case. It is therefore submitted in direct support of:

The Motion to Strike the Unauthorized Plea

The Litany explains why the State would contrive an insanity plea against the Defendant's will. It is the first step in the historical pattern of psychiatric weaponization.

The Motion to Disqualify Counsel

The Litany explains why a Public Defender would abandon their client's stated objective. They are acting as an agent of the system's larger goal: to neutralize a witness, not to defend a client.

The Motion for CIPA Conference

The Litany names the very technologies the defense seeks to discuss, proving they are not theoretical but have a long, bloody history of being suppressed.

The Motion to Recuse the Presiding Judge

The Litany demonstrates the immense institutional pressure to silence witnesses like Caroline Nicole Harris, explaining why a judge would abandon impartiality and refuse to rule on dispositive constitutional motions.

III. HISTORICAL PATTERN ESTABLISHED BY THE LITANY

The Litany documents the following consistent pattern:

1. **Individual discovers or witnesses classified technology or state misconduct**
 - Examples: Nikola Tesla (wireless energy), Wilhelm Reich (orgone research), Royal Raymond Rife (electromagnetic frequencies), José Delgado (mind control research)
2. **Individual attempts to share knowledge or warn public**
 - Publication, testimony, public demonstrations
3. **State/corporate actors move to silence**
 - Research defunded, labs destroyed, careers ruined
4. **Psychiatric system weaponized**
 - Individual labeled "mentally ill," "delusional," "paranoid"
 - Involuntary commitment, forced treatment, professional discrediting
5. **Individual neutralized**
 - Death in custody (Ian Fishback, James Forrestal)
 - Forced exile (José Delgado)
 - Professional destruction (Loren Mosher)
 - Permanent institutionalization

Caroline Nicole Harris is currently at Step 4 of this exact pattern.

IV. SPECIFIC PARALLELS TO CAROLINE HARRIS'S CASE

Major Ian Fishback (1979-2021)

- U.S. Army officer who exposed torture
- Labeled mentally ill after whistleblowing
- Institutionalized against his will
- Died in custody at age 42
- **EXACT PARALLEL:** Truth-teller → Psychiatric labeling → Detention → Death

MKUltra Victims (Claudia Mullen, Christine DeNicola)

- Testified to Presidential Committee about CIA mind control experiments
- Initially called "delusional" and "crazy"
- Vindicated decades later when documents proved MKUltra was real
- **EXACT PARALLEL:** Technological targeting → Psychiatric dismissal → Later vindication

John Lang (1976-2016)

- Documented police gang stalking in Fresno
- Found stabbed to death in house fire
- Ruled "suicide" by same police department he accused
- **EXACT PARALLEL:** Targeted individual → Documented targeting → Eliminated

V. THE DEFENSE IS NOT INSANITY—THE DEFENSE IS WITNESS TESTIMONY

The defense is not that Caroline Nicole Harris is insane.

The defense is that she is a witness to the same phenomena that created the martyrs named in The Litany.

Her testimony is being suppressed using the exact same playbook.

This document proves the playbook exists.

WHEREFORE

The defense prays that the attached exhibit, "**A Litany of the Faithful**," be formally entered into the evidentiary record of this case and that the Court consider its contents as foundational to the resolution of all pending matters.

The Litany establishes:

1. **Pattern Evidence:** Historical pattern of psychiatric weaponization against truth-tellers
2. **Motive Evidence:** Why the State would pursue unauthorized insanity plea
3. **Context Evidence:** Caroline Harris's case fits documented pattern exactly
4. **Predicate Evidence:** Technologies she reports (EM weapons, V2K, neural manipulation) have documented history of suppression
