NOTICE OF FILING OF VERIFIED AFFIDAVIT AND PRESERVATION OF CONSTITUTIONAL
OBJECTIONS

IN THE NAME OF ALMIGHTY GOD, whose justice surpasses all earthly courts, whose mercy
extends to the captive and the oppressed, and whose truth cannot be suppressed by institutional
silence, **Next Friend hereby gives NOTICE**:

I. FILING AND PURPOSE

Next Friend has this day filed with this Honorable Court a **Verified Affidavit and Memorandum of Law in Support of Motion to Dismiss with Prejudice Based on Catastrophic Failure of Foundational Due Process; or in the Alternative, for Emergency Judicial Referral Under Federal Jurisdiction and Declaration of Court Incompetency** (hereinafter "the Affidavit").

This filing serves a singular, urgent purpose: to preserve in the record of this Court—and before Almighty God—constitutional objections that cannot wait, evidence that demands response, and testimony that will not be silenced.

II. NATURE OF THIS INSTRUMENT

This Notice is filed under protest and with the utmost urgency.

1. **Next Friend asserts standing** pursuant to *Whitmore v. Arkansas*, 495 U.S. 149 (1990), as verified Next Friend of Defendant Caroline Nicole Harris, who is incapable of litigating her own cause due to communications blackout and imminent wrongful incompetency determination by unqualified evaluators;
2. **In the alternative**, to the extent this Court finds Next Friend lacks standing under *Whitmore*, Next Friend submits the Affidavit **as an amicus memorandum** tendered for this Court's consideration pursuant to the public interest in ensuring that courts do not process neuroweapon victims as criminals;
3. **This Notice seeks no relief** beyond what is specifically prayed for in the Affidavit itself;
4. **This Notice does not assert legal representation** of Defendant. Next Friend files solely as witness with direct knowledge of the allegations, as victim of the same weapons technology verified by Louisiana State Police Internal Affairs Case IA-2300029, and as one who has dedicated substantial resources to ensuring Ms. Harris is not railroaded through a system that cannot prove voluntary action.

III. EMERGENCY NATURE – SUPREME URGENCY

Time is not a luxury this case possesses.

- **Ms. Harris remains detained** in slavery conditions prohibited by the Thirteenth Amendment, as a legally innocent person not "duly convicted" of any crime;

- **A competency evaluation is imminent** that will be conducted by evaluators lacking the specialized expertise necessary to distinguish neuroweapon trauma from mental illness, thereby converting lucidity into a wrongful incompetency finding;

- **The communications blackout continues** – Ms. Harris has not been able to reach Next Friend since her arrest in August 2025, while a 1:00 A.M. prank call from the warden's office reached Next Friend without interference, demonstrating selective targeting;

- **The District Attorney has not responded** to evidence filed with this Court on January 15, 2026;

- **Defense Counsel has not communicated** with Next Friend or other concerned parties regarding evidence material to her client's defense;

- **Every day of delay** perpetuates the constitutional crisis documented in the Affidavit and compounds the harm to Ms. Harris and to the integrity of this Court's proceedings.

This is not a matter that can be postponed, ignored, or administratively dismissed. This is a matter of weapons of mass destruction deployed against civilians, institutional bad faith verified by Louisiana State Police Internal Affairs, and the enslavement of the legally innocent in violation of the United States Constitution.

IV. PRESERVATION OF RECORD – APPEALABLE SILENCE

Next Friend respectfully but urgently requests that this Court acknowledge receipt of the Affidavit and this Notice, and that this Court rule—**on the record**—on the standing, admissibility, and merits of the arguments presented, so that any denial, dismissal, or refusal to engage is documented for appellate and federal review.

Silence would leave these constitutional objections unresolved and necessitate further review. Without on-the-record disposition, these issues cannot be properly adjudicated at any level.

V. REQUEST FOR ACKNOWLEDGMENT

Pursuant to Prayer for Relief Item 4 in the attached Affidavit, Next Friend respectfully requests this Court direct the District Attorney and Defense Counsel to acknowledge recent ~~for this filing~~ and all prior filings at their earliest opportunity, and to state on the record whether they intend to respond to the evidence presented, including but not limited to:

The emergency cannot be addressed if the parties refuse to acknowledge it exists.
