1. (S/NF/SK) TASKING: Ops officer provided monitor with data - (see attached targeting info). Additional information per discussion; project would obviously require many sessions. That it is "important" and, if successful, would be a significant intel accomplishment.

2. (S/NF/SK) SESSION: ~~Target, as described/presented~~ Target, as described/presented elicited a good degree of monitor interest. Source AI indicated a high level of interest, also. In monitor's opinion, the "chemistry" was right for not only a good initial session, but enough site stimuli was apparently present to maintain source interest over a number of sessions.

Upon being provided with encrypted coordinates, source proceeded rapidly through S1 and S2. S3 consisted of a set of sketches that depicted a series of structures. Source was then given a movement exercise, ("from 1000 feet up something should be visible"), and asked to sketch his impression of the site again. This furnished source with a stronger impression of the site. Monitor moved source immediately into S4 and asked him to draw a symbolic diagram outlining the boundaries of the site, (he drew a rectangle).

Source was then directed to label the cardinal directions, then to ~~proceed~~ move from one edge of the site to the opposite end, labeling each perceived gestalt with a number, then entering the (labeled) data into his SC matrix. Source was asked to provide only a general description of each gestalt and ~~do not~~ not be concerned with details until future sessions.

3. (S/NF/SK) SUMMARY: Site is a large, military-like grouping of buildings of different shapes and functions, the role of each, while quite dissimilar, contributes to the overall mission of the site, which is covert, clandestine and compartmented - in the sense of both physical and operational security. There are several sub-activities that are directly related to the site's primary purpose, but these activities are deliberately compartmented from each other so that no one person at the lower functional level can piece the whole "picture" together. A man with a beard was perceived, who feels that what he is working on is something that he absolutely does not want to become widely known. He is concerned that, somehow, information will "leak out." He feels that his operation is the target of information collection activities; but its primary protection lies in the fact that searchers don't know where it is or what is going on. [Site's mission is weapons development (non-nuclear); possibly biochemical or energy related.] AD!!!

4. (S/NF/SK) FEEDBACK - 1/2way through the session, source inquired 1) if site was operational and 2) if it was "new." Monitor replied in the affirmative to both questions and further stated that source should take his time with the target because it would be worked on over many sessions (and that by the time we complete it, it would be "old").
