Dear Dennis:

At approximately 9:40am today Nils Alan Forsman arrived by taxi at the Main Gate entrance to the estate. Kevin Costello spoke to Forsman and recognized the name from the information provided by you in July 2012. Forsman gave me his valid California driver's license showing his residence as 235 Arlington Rd 307, Redwood City, CA 94062, D.O.B. 10/3/1967 The phone number he gave is 650-839-0391 which upon checking is apparently his ex-wife's residence.

We interviewed Forsman at the Main Gate and he stated that he believed he was Margaretta Fitler Rockefeller's missing son. He allowed me to video him explaining his story and also allowed me to take several pictures of him. He stated that he arrived at JFK this morning from a red eye flight from San Francisco CA and traveled to Grand Central Terminal and took a train to Tarrytown. A taxi transported him from the train station to the Main Gate. He had two pieces of luggage, a small shoulder bag and a large roller suitcase.

Forsman stated that his mother, Helvi Alice Forsman, was a nanny at Kykuit from 1957 to 1964. He did not have a logical explanation for the fact that Margaretta had a child born the same year he was born in 1967 and said that possibly he was involved in a baby swap. There were no indications of any aggressive behavior to any Rockefeller family members and no threats were made, however, it was apparent to me that he was not completely coherent. He requested a face-to-face meeting with Margaretta Rockefeller. He never referred to Mrs. Rockefeller as Happy. He also said he would like to have a DNA test done to confirm that he was a Rockefeller, and he said that a blood test confirmed that Helvi was not his mother. Forsman also stated that he was an orphan and that he spent some of his childhood in Dobbs Ferry at St Christophers School.

I advised Forsman that he would not be able to meet with any Rockefeller family members and that he would be arrested if he attempted to make contact in any way or if he returned to any of the Rockefeller owned properties. He did not get upset when I advised him of the above restrictions. When asked where he would go after he left the estate, he said he would return to California immediately.

The Mount Pleasant Police detective division was contacted and Detectives Arthur Romaine and Matt Brown arrived a short time later and met with Forsman at the Main Gate. He was personally patted down and searched for their safety and nothing unusual was found. He allowed the officers to look into his bags also. He was advised by the police officers that he would be arrested if he returned to the area or attempted to contact any of the Rockefeller family. A criminal warrant check was completed before Forsman was allowed to leave the area by taxi. The taxi was followed and it was confirmed that Forsman entered the train station for a southbound train.

It is unknown if he will take a plane back to California or if he has contacts in NYC or elsewhere in the area. He did have a large amount of clothing in his suitcase indicating he was prepared to have a long stay in the area.

I scanned his personal notes that he allowed me to take and will forward them via email along with the still pictures I took of him this morning. One concern about the notes: most of the names are the result of internet searches but Jay Rockefeller's West Virginia business address is included. There are also several Rockefeller addresses noted from California that have no connection to JDR family members. I spoke to Tony Burti this morning and he mentioned that you relayed some of the information to him earlier.
