We just received shipping instructions for Tranche 161, the orders were placed back in February/March. So here are a few items I see of interest...

- Average time appears to be that 6-9 month window LESO told us
- Average cost looks like it's going to come in under a \$100 for per M16 (this includes the shipping and state processing fee)
