- (S/NF/SK) Cuing: 6-digit encrypted coordinates: 805305/165518, and "K-13".
- (S/NF/SK) Tasking: Determine if a targeted event (K-13) will take place in South Korea between November, 1988 and May, 1989.
- (S/NF/SK) Methodology: RVer consciously worked between the years of 1988 and 1999. First part of session was worked ERV, second part was worked CRV. Stages 5 & 6.
- (S/NF/SK) Results:
- The first part of the session produced a "growth chart" (see session transcript, page 1) in which the "present line" rises and falls over a period of time, with a generally At a point, however, a "new line" begins and rises rapidly to overshadow the "present line".
- The "present line" gave an impression of white 1) color, governmental economics, cleanliness.
- The "new line" gave the impressions of being dark and metallic, somewhat sinister, and very serious. gave the allegorical impression of the "jaws of a steel trap".

- 3) The point at which the "new line" overtakes the "present line", there is an impression of the death of a leader. This death was seen as quiet and easy (no violence), but carried the definite impression that it was caused.
- b. The second part of the session produced a time-line with the following impressions (see page 3 for the location of each impression along the line):
- 1) Impression of a young male in a limousine, admiring his own femininity.
- \downarrow 2) Impression of a very large, governmental or pala ϕ ial building.
- 3) Impression of a small, wild animal hiding from someone who is hunting it.
- 4) Impressions of written material, beginning a series of impressions along the time-line of "revolutionary" and "revolution".
- 5) Visual of a large complex of brand new, very large machinery (AOL: like a huge generating/air conditioning /etc. plant).
- 6) Visual of a long row of very large, circular machines (see sketch, page 4) (AOL: strong impression of it being a generating station).
- 7) Visual of a man smuggling a woman into a doorway.
- 8) Reprobing the time-line, in conjunction with the "growth chart", produced the same impression of the leader's quiet death at point 8.
- c. I strongly suspect that many of the impressions gained were allegorical in nature.
