PART 1: Introduction to the Juvenile Justice System
Describe the history of juvenile justice in the United States.
Define "juvenile court" and the role of the Juvenile Judge or commissioner in juvenile court matters.
List the role and responsibilities of the juvenile officer or deputy juvenile officer, including their ability to make arrests.
List 3 juvenile terms and their related adult terms.
Define the term "child" per the Missouri statutes.

Explain what is meant by venue in juvenile/family court cases.
PART 2: Role of Law Enforcement
What do the statutes indicate regarding law enforcement officers assisting and cooperating with juvenile officers?
The two types of judicial custody are:
Identify the circumstances and situations when a juvenile may be taken into judicial custody, if it is this an arrest, and when the jurisdiction of the court attaches.
Identify the process for the execution of a capias, as used in judicial custody situations.
Identify who is to be notified when a juvenile is taken into judicial custody?

Identify the procedure for notification of the Juvenile Officer when the juvenile is or is not released.
What conditions must exist for a juvenile to be released from custody?
Can a juvenile be detained in a jail or other adult detention facility?
Describe the procedure when a juvenile is presented to the juvenile officer or detention facility.

What rights is a child to be given after being taken into custody and prior to questioning?

What happens if a child is still under the jurisdiction of the family/juvenile court but is older than 17 and commits a new law violation, and where he/she goes to court?
