



- 1. (S) Source was requested to seek out information on the above target, but was only provided the coordinates for the target. The following information was provided and is applicable to 0900 hours on the 24th of June, 1980:
- a. (S) Source reported long rectangular boxes which reflected white and had V-shapes along their top edges. He stated that they looked very much like semi-tractor trailer boxes. These items are reported as being along the side of a single railroad track.
- b. (S) Source also stated that there was a large structure which was square in design and composed of many trailer boxes all connected together. Source stated these were long and narrow, numbering approx. 36.
- c. (S) He also stated that approximately a quarter mile away there was an inflatable hospital type of structure made of some pliable material like plastic or rubber.
- d. (S) Source reported approximately 7 armored vehicles with large cannon moving in the area; as well as many trailer trucks loading up with equipment and containers and moving out from the area. He stated that there was also a truck type of vehicle which looked like it was loaded with stacked, large, rubber pillows, very much like fuel bladders. He did not report any off loading in the area.
- 2. (S) Request the above information be evaluated and comments be provided to the undersigned in writing no later than 02 July 1980, this will permit a full evaluation of the source of information for both accuracy and intelligence value.





#### CUING INFORMATION

SG1A

(S) Both the facilitator and remote viewer were provided with the target location in geographic coordinates; In addition the facilitator was directed to obtain as much information as possible on the target site, as well as direction to persue any information available if the viewer reported military equipment of any kind, particularly in regard to numbers. The facilitator was directed to persue the numbers question only if this could be done without leading or cuing the remote viewer, this was accomplished.
