2. Ref a established milestones for implementation of HQ INSCOM reorganization and creation of the 1st I&S Bde at FGGM. HQ INSCOM will be consolidated at AHS, VA. ✓  
This will involve the collocation of ADCSOPS-HUMINT and DCSCI with the rest of DCSOPS. These actions were announced in refs b and c above.

3. The HUMINT mission of the Bde will entail command and control over only the USAOG (no OCONUS MI Gps) and such other operational functions currently performed within HQ INSCOM as are appropriate.

4. The first reorganization milestone is the division of functions described in ref d above between HQ INSCOM (ADCSOPS-HUMINT) at AHS and the Bde HQ at FGGM. In doing this, we must consider the draft revised functions (distributed via OF 41, 14 Nov 79) which have been prepared for our current provisional organization. A very close look must be given to the line functions performed within the ADCSOPS to identify those which could be delegated/assigned to the Bde G-3 staff and/or USAOG, as well as the staff functions which the Bde G-3 Staff must perform. Possibilities of line functions which could be transferred include:

TOUR TRAIN Management

CONUS TAREX Library and Collection Functions

HUMINT REDTRAIN Management

5. Another factor to consider is the function which will dissolve with DCSOPS consolidation in one location. An example could be the administration of a separate SII account and related tasks (CMB function).

6. Request addressees review their functions and tasks currently performed, those stated in Incl 2 and the draft ADCSOPS-HUMINT O&F manual and provide consolidated
